Dr. Kales is an Associate Professor of Medicine at Harvard Medical School, and Associate Professor & Director of the Occupational Medicine Residency at the Harvard School of Public Health. Dr. Kales is also the Chief of Occupational & Environmental Medicine and Medical

Director for Employee Health & Industrial Medicine at the Cambridge Health Alliance, a Harvard-affiliated hospital system, as well as, faculty in the Harvard Division of Sleep Medicine. He was among the first occupational

medicine directors to institute an objective obstructive sleep apnea (OSA) screening protocol for commercial drivers in a busy clinic dealing with driver medical certifications. His group's publications have demonstrated significant gaps in current regulations that allow operators with undiagnosed and or untreated OSA to continue to drive, constituting a significant risk to themselves and the general public. He has lectured at regional, national and international meetings on this subject, and is a recognized leader in the area, including keynote lectures at the Japan Society of Occupational Health; joint activities with the International Association for Traffic Safety Sciences and senior author of a chapter on OSA in the workplace in the foremost sleep medicine textbook, The Principles and Practice of Sleep Medicine. In 2015, he was awarded a National Sleep Foundation contract through Harvard to create a continuing medical education video course on sleep disorders for sleep clinicians and commercial driver medical examiners. Most recently, he was the senior author of the largest and most rigorous study to date of OSA and truck crash risk among commercial drivers (SLEEP 2016) finding that treatment-non-compliant drivers with OSA had a rate of preventable crashes five-fold greater than control drivers matched for driving experience. These new findings and a separate commentary in *SLEEP* (2016) that Dr. Kales authored are influencing the national debate on mandating the screening of drivers and other transportation operators for OSA.

Dr. Kales has participated in a wide range of medical/public health research, advisory and teaching activities on five continents resulting in over 145 publications and wide recognition nationally and internationally. He also serves on the editorial boards of several biomedical journals.

Dr. Kales has received several prestigious honors recognizing his outstanding scientific contributions to the field of occupational medicine. These include: the Kehoe Award for Excellence in Education and Research from the American College of Occupational and Environmental Medicine (ACOEM); and the Harriet Hardy award from the New England College of Occupational & Environmental Medicine; induction into Brazil's Emperor Dom Pedro II Order of Merit and a special research award from the International Association of Fire Chiefs.


