## Call for Poster Presentation Abstract

The Poster Presentation Session is scheduled for the evening of **Thursday, December 5th, 2024** in conjunction with the President’s Reception, from **5:30 to 7:00 pm** in the evening.

### Submission of Poster Abstract Guidelines:

- Submissions accepted from occupational health nurses, physician assistants, physicians, fellows, including those in residency training, medical school or nursing school, industrial hygienists, students of related disciplines and other OEM related professionals are all welcome.
- Posters may focus on research results, case reports, educational projects or professional development. Posters may address any topic relevant to Occupational and Environmental Medicine. Submissions should ideally represent recent work.
- Author(s) may submit more than one abstract for review.
- If accepted, the author(s) or designate must register for at least one conference day and be present for the poster session on Thursday, December 2<sup>nd</sup> from 5:30 to 7:00 pm.
- Posters must be free of any commercial interest. The ACCME defines a “commercial interest” as any proprietary entity producing health care goods or services, with the exemption of non-profit or government organizations and non-health care related companies.

In order for your poster presentation to be considered for Continuing Education credits, submission of this “Call for Poster Presentation Abstract” form by **May 15th, 2024** is preferred.

*\*Note: The deadline for your printed poster will be in late fall, just prior to the conference dates.*

## Submission Review Process:

All submissions will be reviewed by the NECOEM/MaAOHN Annual Conference planning committee. The review will focus on the following:

- Significance of the findings for Occupational Health practitioners
- Clarity and quality of the presentation
- Quality of the research methods used
- Absence of commercial interest

Decisions will be made and communicated as soon as possible after submission.
